117. Chairman Cllr Neil Jones thanked everyone for attending and opened the meeting.

119. Declarations of Interest, none

120. **Police Report** – incidents of metal theft and hare coursing have been on the increase, these are being targeted by police any information should be reported immediately to the new none emergency number 101

121. **Langrивille – Christmas tree lighting ceremony**, Cllr Mrs Betty Harvey has donated £250 towards the cost of the lights from the BIG Society fund, she will be coming along to switch on the lights and refreshments will be served. 3rd December at 6pm.

122. **Diamond Jubilee Celebrations**- Langrick Diamond Jubilee Fete will be held at Clover Farm Langrick this will be a traditional fete, local schools and uniformed youth groups will be invited to contribute help and entertainment alongside other attractions, a committee for the village fund will be shortly formed to make further arrangements.

123. **Langrick Church Hall** – no further information has been received from the diocese but local PCC have informed us that the lease will not be forthcoming; It was **RESOLVED** that if this is the case then alternative suggestions are to be sought, this will be the subject for our Annual Parish meeting to be held March 12th 2012.

124. **Accounts for payment**, It was **RESOLVED** to pay the following Clerks Salary Oct/Nov £237.46; Dec/Jan £237.46 – reimbursement of funds Christmas lights and fittings £275, Langrick Church Hall Fund £60 hire for meetings.

125. **District Councillors Report** – Councillor Steve Doughty still has money available from his District Community Fund and offered to help with payment for the live music for the Jubilee Fete; he has moved from the Independent group and is now a member of the District Independents.

126. **East Lindsey District Council Communications** – questionnaire completed and returned comments regarding the effectiveness of the area committees and various ways of

communicating with other councils discussed, this council felt the area committees did not work for the smaller council.

127. Planning - S/096/01974/11 Calahonda, Armtree Road, Langrick- erection of double garage at front of property – **S/096/01466/11 Antons Gowt Lock – full planning permission granted.**

128. Highways – Concerns over the speed of traffic on Armtree Rd – after discussion; It was **RESOLVED** to request an Archer survey be carried out by the Road Safety Partnership, clerk to contact to arrange. Various road repairs including B1184 at junction B1192 and by the bus stop (Anglian Water sunken repair) B1184 from Gipsey Bridge towards Langrick dangerous subsidence and breaking up of road surface; B1192 between Clover Farm and junction of Haven Bank towards Coningsby subsidence has had a temporary repair this is already sinking. White lines and right of way markings need re painting at Anton's Gowt Bridge, Ferry Road sign at end of Armtree Rd has gone missing. Clerk to inform Highways and Anglian Water of the above problems.

129. Items for January 2012 meeting – Budget; Diamond Jubilee Fete, Areas within the Parish for designating as building land.
