**29. Welcome from Chairman Cllr Neil Jones**, giving thanks to Mrs Joan Roseveare for helping out during the clerks absence, a letter of thanks to be forwarded

**30. Apologies and reasons for absence** – Cllr Mrs Annabel Marshall were heard and accepted.

**31. Declarations of Interest** – None at this point.

**32. Notes of meeting held July 5<sup>th</sup> 2010** previously circulated resolution to adopt as true record, all in favour, minutes were signed and dated.

Two items to be clarified, 1. District Cllrs community fund is not available to the parish council as it has been in the past because the council can raise by precept for items required/ requested by parishioners, the fund is available to groups, clubs or individuals who can prove a need for their request for funds to the District Councillor.

2. Water Railway – Keys, all emergency services should hold the keys to the gates, Council resolved to purchase two keys one to be held at the Ferry Boat Public House and one at the Malcolm Arms with a notice to this affect to be placed at the gates, this is subject to approval of the publicans & Sustrans.

**33. Police report** – We have a new PCSO Emma Gardiner-07944776706 also the contact for police has changed to Lincolnshire Police non emergency number-0300 111 0300; Emergency calls 999

**34. Clerks Salary review** – discussion took place at meeting July 5<sup>th</sup> minute number 26, **Proposal to increase salary by £250 per annum from today 6<sup>th</sup> September 2010, seconded, all voted in favour.**

**35. Planning** – two investigations are ongoing in the parish both residents/owners have been sent requests from ELDC to apply for planning permission for the developments/ changes they are making. Council requested clerk write to ELDC asking for the policies to be reviewed regarding none communication from owners and planning.

**36. Seat Gipsev Drove Bus Stop – Proposal to purchase a bench seat, pending permission from Lincolnshire Highways, seconded, all voted in favour.** Clerk to follow this up, place on next months agenda.

**37. Accounts for payment** –Cheque £18.50 to LALC **minute no. 25 July 5<sup>th</sup>.**

**38. Trees & Hedges at Lock approach Anton's Gowl** – after discussion it was proposed that council request quotes from three local contractors to price for cutting these trees back to the fence line on an annual basis, contract length would depend on quality of work, all contractors must provide copies of public liability insurance with quotes- to be discussed and decided at November meeting. Clerk to write to contractors.

**39. District Councilors Report** – Steve Doughty; Driver training is available for the over 65's free, this would be useful to update drivers on new laws, modern technology and good driving practice.

Cannister Lane is going to be resurfaced and could be closed at times between 4 October and 6 November.

**40. Clerks Report** – Speed indicators have been in the village for two weeks located in several place around the parish results show 48% of the traffic through the village are traveling over the speed limits, an Archer survey has been requested and the results sent on to the RSP for analysis.

Request for the Willow trees at Bream cottage Anton's Gowl to be pollarded has been received by council, this work is long over due and should be completed by end October, long term suggestion to approach the owners of the trees Lincolnshire County Council to remove them completely due to all the problems caused by roots in the drainage system, clerk will look into the rules of having a preservation order lifted.
