Meeting 4th June 2011

Public Forum; Residents from Anton's Gowt asked if Council had any information about a proposed Car Park in the village, they had serious concerns about visitors abusing the surroundings, Council have no knowledge of any current plans to build or provide any additional Car Parking, some time ago an application was placed to possibly build some moorings alongside the Malcolm Arms Public House, these plans never came to fruition as the funding was not available.

Thank you for getting the waste bins changed at the lock approach, there are still some problems with overflowing general waste bins, Council will check on collection days and report back to next meeting.

Telephone kiosk; Antons Gowt this kiosk is staying and is still a functioning call box, council encouraged persons to use this to continue to make it a viable feature of the village.

Water railway, concerns that the pathway is overgrown and not being managed at all, Council to contact Sustrans to inform them and get information on who is responsible for management.

Willow trees at Bream Cottage have been pollarded by Lincolnshire County Council, a thank you received from the property owner for all the Council and District Councillors help with this issue.

- 91. Chairman Cllr Neil Jones thanked the members of public for attending and opened the meeting.
- 92. No Apologies
- 93. Declarations of interest: Cllr Mrs Annabel Marshall declared an interest in planning item concerning Langrick Grange her family home.
- 94. Draft notes of Annual Meeting held on 9th May 2011 resolution to adopt as true and correct record of meeting, seconded all voted in favour

Draft notes of extra meeting held 31st May 2011 – resolution to adopt as a true and correct record, seconded, all voted in favour, two sets of notes were signed and dated.

95. Police report: a report containing all incidents since the last council meeting had been produced and presented to Council, no major incidents had occurred, Police urged people to

ring in issues of concern to the new number 0300 111 0300 where they would be directed to the correct department.

- 96. Council Finance: Clerks salary June & July £233.67 HMRC £58; resolution to pay accounts, seconded all voted in favour, cheques written and signed.
- 97. Planning S/096/00412/11 Pig Units Gipsey Drove returned with comments S/096/01024/11 Langrick Grange erection of an additional detached garage block within cartilage of listed building, viewed at meeting, Cllr Mrs Annabel Marshall did not comment no objections from Councillors.
- 98. Letter from Chief Constable outlining the new working areas and conditions within Lincs Police force, Council will wait to comment on the effectiveness of these changes giving the officers' time to settle in to new routines.
- 99. District Councillor Steve Doughty reported on the Skegness Festival to be held over the 22-24 July, introduced council to the new "Beach Wheelchairs" available for hire at Skegness; the ELDC is settling down after the elections, lots of new Councillors, the community fund is running again this year with £1,500 available to community groups or projects for the benefit of the parish, persons need to write to Cllr Doughty with their requests.
- 100. Highways After discussion Council requested the clerk contact Highways to ask for a survey to look at possibility of reducing the speed limit to 30mph along Armtree Road, reasons given:- footway along one side of road, all amenities on the opposite side including phone kiosk, post box, notice boards and bus stop, village has had a fatal accident on the corner of Armtree Rd/ Meer Booth Rd just by the bus stop.

Various pot holes and subsidence areas were noted and reported to highways for repair, Gipsey Drove, Junction of Armtree Rd with the B1192 and Leagate Rd Antons Gowt.

- 101. No issues for next meeting, Councillors were reminded they need to get items to the clerk at least 7 days in advance of the meeting date for inclusion on the Agenda, items must be on the agenda for a resolution to be passed.
- 102. Clerks report training events, all councillors have a copy of this year's events, it is most beneficial to councillors to attend some basic training although not compulsory it is helpful.

Reports from the residents of Station Cottages about disturbance from fridge lorries parking overnight, Clerk will speak to the tenant of the Café to resolve this.
