16. Notes previously circulated of meeting held 8<sup>th</sup> May, proposal to accept as true and correct record of that meeting Cllr DE, seconded Cllr JC, all voted in favour, RESOLVED minutes signed and dated by Chairman.
17. Police report – Cllr requested a visit from the police.
18. **Anton's Gowt Lock and Cycle path** – issues with youths swimming in the river, littering around the lock, lots of foul language and rubbish being left around on the grassed areas, could a bin be requested for this area? (the area in question is on the Boston Borough side of the Lock) Motor cyclists are using the bridleway. Clerk to contact Sustrans, Boston Borough Council and the local Police.
19. **Langrick Bridge** – sums of money are being talked about with a view to straightening out the road. County Council will be looking at all options of repair and strengthening before spending any money, Local CC are meeting with Highways officers in the near future to discuss this in more detail. Consultations are due to start this coming autumn; details of any proposals would not be available until this time.  
Proposal Cllr NJ to look at the possibility of listing the bridge as a local landmark structure, seconded Cllr PC, all voted in favour – Clerk will look at the requirements for this and bring back to next meeting.
20. **Cllr Tom Ashton – County & District Councillor – East Lindsey** – the way planning applications are called in for committee decision rather than delegated is being investigated, much tighter rules are being imposed and clear planning reasons must be evidenced and the only person that can call in an application would be the Cllr elected for the particular ward.  
**Louth Market** – consultation has been launched to find out what people want to see on the Cattle Market site it is important that people put in their views either online or by requesting a paper copy. Proposal to write as a Parish Council voice to save the site from development but to request that East Lindsey try to change the Charter deeming that it must be a cattle market, Cllr DE seconded Cllr JC all voted in favour RESOLVED.  
**Lincolnshire County Council** – surface dressing is currently being done and some emergency patching to try and extend the life of the roads and make best use of the available funds.
21. **Planning – S/096/027472/16** Land to the North of The Retreat, Leagate Road Anton's Gowt – full planning permission for four homes in total.
22. **Finances – Grass** cutting £100, Clerks salary £270.40, HMRC £67.60 Hall electrics £38.71, Anglian Water hall £17.42
