- 1. Cllr Mrs Ann McGovern called for **nominations of Chairman** to this Council for the coming year; **Cllr Neil Jones** was nominated, seconded, all voted in favour of Cllr Jones position as Chairman, Cllr Jones was not present but had sent written confirmation to the clerk that he would be pleased to stand as Chairman if nominated. Declaration of acceptance to be signed at next meeting. *No other nominations were heard*.
- 2. Nominations for Vice Chairman Cllr Mrs Ann McGovern nominated, seconded, *no further nominations heard;* all voted in favour of Cllr Mrs Ann McGovern; Cllr McGovern signed the declaration of acceptance of office agreeing to abide by the code of conduct for local councils.
- 3. Other officers nominated Cllr D Eaton Secondary Finance & Flood Warden, Cllr Peter Wallis Communications; Ian Paton is the local Tree Warden and has once again carried out our Internal Audit. All agreed to continue/ take on these roles within the Council.
- 4. **Apologies** and reasons for absence Cllr Neil Jones & Cllr Peter Wallis resolution to accept.
- 5. Declarations on Interest none at this point.
- 6. **Notes of meeting held January** 11th 2010 previously circulated, resolution to adopt as true record, all in favour, minutes were signed and dated.
- 7. Police not in attendance, there have been a few incidents in the parish, it was requested the clerk try to get police to attend next meeting if possible.
- 8. Councils, **Risk Assessment and Financial** regulations policies were reviewed, no changes were made these were adopted to be followed for 2010/11
- 9. **Standing orders** all councillors to be issued with model standing orders part 2, these cover the code of conduct and procedures more in depth; resolution to adopt, seconded, all voted in favour.
